Sandra Fox opened the meeting with introductions and by stating the instructions for submitting bids. All Bids must be received in the Office of the Maryland Stadium Authority located at 333 West Camden Street, Suite 500, Baltimore, Maryland 21201, **no later than 11:00 a.m. on February 21, 2018.** Late, faxed, or emailed bids will not be accepted. There is not an MBE participation goal established for this procurement. Prospective bidders were urged to check the website for future addenda. It is the Bidders' responsibility to make sure they have received all appropriate documents, prior to the bid due date. All Bidders must be registered with eMaryland Marketplace in order to receive a contract award. The term of the contract shall be three (3) years with for two (2) renewal options for a term of one year at the sole discretion of MSA.

Bidders were advised to pay close attention to 4.1- 4.8 for bid format. All questions must be submitted to Sandra Fox preferably by email at sfox@mdstad.com.

Vince Steier described the components of the project and stated that the details are in the scope of work. Pre-season sound system check must be completed at least fifteen (15) business days prior to each season's baseball Opening Day. Mid season check must be performed and completed during the baseball All-Star Break, or as scheduled by MSA. Repairs are needed to the sound systems in each building during the term of this contract. Most events are during premium hours, evenings and weekends. MSA utilizes a computerized maintenance system (CMMS) for scheduling and planning repairs as well as preventative maintenance.

Questions and Answers

1. What company has been servicing and maintaining the systems at both stadiums for the past 5 years?

Washington Professional Systems.

2. Is there current as-built documentation or drawings and lists of any upgrades that have been completed to the stadium sound systems in the past 10 years?

Yes, for both Oriole Park and M&T Bank Stadium. We will post these to a shareable folder, or we will share them via another method, per the direction of our procurement office.

3. Will there be any leftover warranty period on the existing system equipment or upgrades that were made and will it be transferable to the new contractor?

There will be a two (2) year warranty period on new equipment at M&T Bank Stadium, being installed Spring 2018. The warranty will NOT be transferred to the new contractor; it will remain the responsibility of the installing contractor. This condition is reflected in the calculations in the annual anticipated maintenance needs in both buildings, in the bid form.

4. Do you have, if any, all passwords, source and configuration files for the DSP and any control programs for the sound system.

Yes.

5. Are you currently using a standardized list or procedure created to validate prior servicing or do we create our own?

MSA uses facility management software called AwareManager to track equipment repairs, project and preventative maintenance on all equipment. The provider will be expected to utilize this software when on site, complete daily work tickets, submit receipts, and complete work orders as dispatched as part of this system. Our maintenance records provide several years worth of data on our repair history.

6. Is the bar included?

The bar in the Warehouse, "Dempsey's," is not part of this scope of work.

7. Do you keep a log of sound complaints "problems"?

Yes, through Aware Manager work tickets.

8. Have there been upgrades done? If so when, where and by whom?

The sound systems in each building are largely unchanged from renovations performed in the late 2000's. At Oriole Park, the most notable change was the addition of the Centerfield Rooftop Bar. The bar was added prior to the 2012 season; the sound system was added prior to the 2013 season. It is integrated with the existing BSS London system.

9. Are their existing drawings?

There are as-built drawings available for the sound systems in each building.
