MSA is issuing this RFP to select a highly qualified firm to perform tax consulting services on an on-call basis for various MSA projects.

# OFFEROR'S QUALIFICATIONS

Please refer to section 2 of the RFP. Offerors must meet the following minimum qualifications in order to be considered for this RFP:

- It shall be a firm with a minimum of seven (7) years specializing in providing accounting and tax consulting services and is registered to practice in the State of Maryland;
- In the last seven (7) years, the Offeror must have acted as a tax advisor for at least five (5) state or local bond issues;
- In the last five years, the Offeror's proposed key personnel must have acted as tax advisors in at least three (3) issues of tax-exempt bonds, of which two (2) of them are public issues; and
- Has the ability to meet insurance coverage requirements outlined in the Sample Contract, included as Attachment C to this RFP.

## **SCOPE OF WORK**

This RFP will be the basis for selecting one firm that will be issued task orders related to the bond issues as needed. Specifically, MSA is looking for firms that specialize in Section 118 of the Internal Revenue Code and provide advice in the creation of affiliates or subsidiaries that would allow for tax-exempt financing.

- ❖ The Selection Committee will review the Offerors' Technical Proposals upon submission. Firms deemed as meeting all requirements will be ranked and, based on the achieved rankings, selected firms will then be "short-listed."
- Those short-listed firms will be asked to attend an oral presentation. After oral presentations, the Selection Committee will select which short-listed Offerors will be requested to submit a Financial Proposal.
