MSA is issuing this solicitation to select a highly qualified Architect/Engineer firm to provide preliminary design services related to the potential development of a new public safety facility on the campus of Coppin State University. The Offeror selected for award under this RFP will work closely with MSA and other Project Team members in the analysis of the overall viability of the Project.

- ❖ Ability to meet the insurance coverage requirements.

MINORITY BUSINESS ENTERPRISES

- ❖ Minimum overall MBE subcontract participation goal is 35% with the following sub-goals: 7% African-American, 10% Women-Owned.
