## Questions and Answers

1. The paint specifications on page 5 under 1.9 warranty states “The applicator shall furnish a twenty year warranty to the Owner for all types of new coating installed. New coating work shall be warranted against defects due to installation, including but not limited to debonding and peeling due to inadequate preparation. “I have checked the bonding company for the 20 years labor warranty and the response was: “Yes, the 20 years applicator warranty is an issue - no one in the surety business is going to write a bond that guarantees the applicator’s work for 20 years.”

### **MSA’s response:**

MSA is not asking for a warranty bond. As stated in the specifications, the warranty is to be provided by the company that installs the coating “against defects due to installation, including but not limited to debonding and peeling due to inadequate preparation.”
