## Questions and Answers:

1. What is level of integration which we need to consider with regards to Integration with third-party applications. Do we need to have any data integration with the CMS database as part of the third-party API's that you intend to keep?

To the best of MSA's knowledge, the following modules need to be upgraded: Auto Entityqueue; Field Group; Recaptcha; Webforms; Calendar Contrib; Schedule Updates Contrib; Custom modules (See question 14 below).
