SCOPE OF SERVICES

MSA is issuing this solicitation to select a highly qualified firm to provide design/build services related to the improvements for Harry Grove Stadium. The stadium is located in Frederick, MD and is the home of the Frederick Keys and the Spire City Ghost Hounds. The project will be designed to ensure compliance with the Professional Development League Standards recently adopted by MLB.

MSA encourages MBE firms to respond to this solicitation.

SCOPE OF SERVICES

Services include, but are not limited to:

- Design and pre-construction services
 - Design and engineering, scheduling, cost estimating, constructability analysis, logistics planning, value engineering, preparation and submission of a GMP proposal for the execution of the Project.
- Construction Services
 - Construction administration services, project management and field supervision, construction, safety and quality control, per Article 4 of Attachment J.

The GMP limit for this Project is \$17.5 million dollars.

- ❖ The Selection Committee will review the Offerors' Technical Proposals. Firms deemed as meeting all requirements will be ranked and, based on the achieved rankings, selected firms will then be "short-listed" to participate in oral presentations.
- ❖ After oral presentations, firms will be short-listed again. Those firms will be invited to the Financial Proposal phase.

Site Security

- Facility lacks a central security command post.
- Facility lacks 24/7 video surveillance system.
- There is no secured player parking area.

Existing Home Clubhouse Facility

- Lockers do not include lockable storage compartments.
- There is not a designated commissary space and many of the associated equipment requirements for the space are not present.
- Current training room space is too small (at ~334.75 SF).
- Current training space does not include the minimum required amenities and equipment (Only 1 full body whirlpool present and no stationary bike present).
- Team Laundry Facility equipment does not meet minimum requirements.
- Team equipment room does not meet the minimum SF requirements. (~28 SF)
- Staff locker room is not adequately sized and is only capable of accommodating four lockers.
- The manager and coaches share grooming / lavatory and shower space. The existing shared space does not meet minimum requirements.
- The manager's office does not accommodate the meeting space requirements.

Existing Visiting Team Clubhouse

- Clubhouse does not meet minimum size requirements. (~555 SF)
- Clubhouse does not provide for minimum required locker quantities (28 current).
- Lockers do not include lockable storage compartments.
- There is not a designated commissary space and many of the associated equipment requirements for the space are not present.
- Current training room space is too small (at ~104.5 SF).
- Current training space does not include the minimum required amenities and equipment (No whirlpools, ice machine, hydro collator, sinks with hot/cold water present).
- Visiting Staff locker / dressing areas do not meet the minimum requirements (~300 SF) and only capable of accommodating six lockers.
- Visiting manager does not have dedicated office.
- The manager and coaches share grooming / lavatory and shower space.
- A dedicated meeting space for the manager is not available.

Additional Team Facilities

- Additional MLB club storage space does not meet requirements. (~36 SF)
- Dedicated female staff facilities are not present.
- No team weight room is present.
- Only one batting tunnel is present and it fails to meet any of the associated minimum requirements.

Internet Services

The existing Primary and Secondary Services do not meet minimum requirements.

Playing Field

Existing outfield walls are not padded.

- Chain link fence walls along portions of the right field / left field foul lines are not properly padded.
- Bullpens are currently located in foul territory of the main playing field area along both the right and left field lines.
- The existing dugouts do not provide for minimum required bench lengths.
- The existing dugouts do not have an anti-skid surface at steps and walkways.
- There is not an existing water sources within 100' of the existing dugouts.
- The existing batters eye does not meet minimum requirements (~28' x 57').
- The existing field lighting system is not compliant and will require replacement.
- The protective netting currently extends to the edge of the dugouts along first and third base lines and will need to be extended to the outfield wall.
