SCOPE OF SERVICES

MSA and Charles County entered into a Memorandum of Agreement that formalizes the relationship and role of each in the execution of necessary improvements to Regency Furniture Stadium to ensure compliance with the Professional Development League Standards.

MSA is issuing this solicitation to select a highly qualified firm to provide preliminary design services related to the improvements for the Regency Furniture Stadium. The stadium is located in Waldorf, MD and is the home of the Southern Maryland Blue Crabs (an Atlantic League Professional Baseball team).

Refer to Section 3 of the RFP for the full scope of work and all references to attachments relevant to this RFP.

OFFEROR QUALIFICATIONS

- Has been in business for at least five years;
- Is an architectural/engineering firm that has members registered to practice in the State of Maryland;
- Has experience in providing design services for Government and/or commercial clients;
- Has substantial design experience related to the renovation and or expansion of existing athletic clubhouse and training facilities at the collegiate level or above;
- Has experience in innovative design methods to meet programmatic goals of building efficiencies, on-time delivery, cost containment, and value engineering strategies; and
- Has the ability to meet the insurance coverage requirements indicated in the RFP.

MINORITY BUSINESS ENTERPRISES

This RFP has a minimum MBE subcontractor participation goal of:

- 29% overall with subgoals of:
 - 7% African-American owned, and
 - 11% Women owned
- All subcontractors named by the Offeror as part of their MBE Schedule must be certified with the Maryland Department of Transportation ("MDOT").
- Offerors' submissions must also include the MBE subcontractor's MDOT certification number & NAICS product and service description of work to be performed. MBE form D-1A must be submitted with the Technical Proposal.

PROPOSAL SUBMISSIONS

EVALUATION AND SELECTION

- Technical Criteria have more weight than Financial Criteria.
- Proposals will be evaluated based on the adequacy of the Work Plan, Offeror's and Key Personnel's experience and qualifications, past performance, and proposed exceptions, among other criteria listed in Section 5.1 of the RFP.
- The Selection Committee will review the Offerors' Technical Proposals. Firms deemed as meeting all requirements will be ranked and, based on the achieved rankings, selected firms will then be "short-listed" to conduct Oral Presentations.
- After Oral Presentations, the Selection Committee will short-list Offerors to participate in the financial phase of the procurement.
- Offerors will be required to provide the password to their Financial Proposal within one (1) Business Day of MSA's request.
- An award will be made to the Offeror whose Proposal is determined to be the most advantageous, considering technical and financial evaluation factors.
