| 2. | We would like to show more than 2<br>Architectural projects, please<br>confirm if that will be accepted.  | Addendum 2 amends the requirement<br>4.3.4.B.a., and three (3) project examples<br>from the A/E are required.   |
| 3. | As this proposal is for preliminary<br>design, please clarify if the work<br>samples should be of completed<br>projects? Can they be from projects<br>different from the project<br>examples? | See the answer to question 1 of this Q&A,<br>and Section 4.3.6 of the RFP.<br>Project Examples and Work Samples shall<br>be from the same projects.   |
| 4. | Please confirm that you need a<br>project for Geo Tech Engineer<br>structural engineer and fire<br>protection engineer.   | Addendum 2 amends the requirement<br>4.3.4.B.f., and a Geotechnical Engineer<br>project example is not required.<br>However, submission of one (1) Fire<br>Protection Engineer project example<br>remains a requirement.  |
