Build To Learn Act of 2020

Presentation by Mr. Johnson

Program Memorandum of Understanding

Mr. Johnson presented the Memorandum of Understanding between the MSA and the Interagency Commission on School Construction required as part of the Built to Learn Act of 2020 which became effective on March 14, 2021 as a result of the legislature's veto override of HB1300.

The Act requires the IAC and the MSA to enter into an MOU to implement the statewide school construction program. The Act requires that individual Project MOUs with local county and/or school boards be developed to execute projects that are to be funded from bonds issued by MSA with an overall debt limit of \$2.2 billion. The first financing plan is currently being drafted and anticipated to be presented to the MSA board for approval in August, with a planned bond issuance in fall 2021 pending MSA and BPW approvals. Mr. Johnson presented a change order request in the amount of \$2,288,355.74 to amend the MCN Build/Southway contract. Baltimore City Schools requested an engineering survey to investigate unforeseen conditions that require repairs and replacement of the roofing substructure. The completion will be funded from the additional savings generated by the program. Included in the change order request are impacts related to COVID-19 safety and screening protocols.
