General Construction Items, 8/1 - 8/31/23

- Project status: Active Construction Site
- GMP Submission Updates:
 - GMP-6 Draft Submitted to MSA for approval (Scoreboard, Railings, Lockers, Millwork, Drywall, Food Service, Site Concrete, Finishes, Low Voltage, etc.)
- Current Construction Activities:
 - Sanitary, storm & water wet utility installation continues along the
 perimeter of the site which will require closing W. Baltimore and Ayer's
 Alley for public utility connections. All road closures shall be
 coordinated through City.
 - Twenty-One (21) underground storage tanks have been discovered to date on the project site, were pumped out under supervision of MDE, and successfully removed.
 - Structural concrete activities continue at main building, which includes pouring mud mat/lean concrete for controlled-modulus columns (CMCs) as well as concrete footings and foundation walls.
 - Continued operation of exporting soils to off-site facilities with MDE's authorization.
 - Under slab plumbing utilities continue at the Southeastern corner of the main building and loading dock including installation of the grease interceptor.
- Upcoming Construction Activities:
 - Plumbing Contractor to continue layout and installation of underground utilities throughout main building footprint.
 - Dry Utility Contractor installing primary and secondary electrical service pathways.
 - Ongoing material deliveries: Piping, Rebar, Cast-In-Place & Nyoplast utility structures, Concrete, Structural Steel, CMU Block.
 - Crane Mobilization for the initiation of structural steel erection at the main building.
 - Waterproofing subcontractor to mobilize for commencement of foundation wall waterproofing.
