
### **Upcoming Construction Activities**

- Job site setup continues in July, including the installation of temporary fencing, the arrival of site trailers, and the connection of temporary utilities.
- Preventative pest control measures have been implemented across the site and will be ongoing throughout demolition and construction.
- Mechanical, electrical, and other utility systems within the Pimlico facility will be made safe (cut and capped) later in the month to prepare for demolition; no disruptions to surrounding community utilities are anticipated from these activities.
- Structural demolition of barns along Belvedere Road and Winner Avenue is anticipated to be completed in July.
- Full demolition activities are expected to commence by late July.
